Dear Future Attorney:

I would like to introduce you to *The Bar Examination Academy* and *Lawyer Makers, LLC*. We teach bar exam applicants how to specifically study and write to pass their bar examinations. We, first and foremost, teach our students the following:

Please note that the difference in passing a bar exam can be less than one (1) point on the essay or performance components of the bar exam. Because many of the students we assist are repeating the bar exam, we do not boast about pass rates because we know that the bar exam is an extremely personal test which requires individual effort, hard work, and the results depend on the amount of work each individual invests into their preparation.

On the July 2020 bar exam, we had five (5) students pass, all achieving extraordinary scores on the Uniform Bar Examination®,¹ *i.e.*, 315, 303, 299, 273, 267. On the February 2020 bar exam, we had five (5) students (all repeat takers), pass including three with extraordinary scores (266+) and at least two who raised their scores by as much as 29 points or more. In the 2019 bar exam cycle, we had students who were multiple-time repeat takers achieve extraordinary² passing scores (280, 276, 272, 270, 266).

On the February 2018 bar exam, we had multiple-repeat takers score 274 and 270 and pass. On the July 2017 bar exam, we had students pass their respective bar exams in the jurisdictions of Arkansas, Alabama, and Tennessee. In July 2016, one of our students, from an unaccredited law school, scored 298 on the UBE. In February 2017 and July 2019, we had students who raised their overall bar examination score by 35 (thirty-five) points and passed.

² An extraordinary score is a score which qualifies the examinee for admission into multiple jurisdictions UBE, *i.e.*, 266 and above. A 266 score, or more, qualifies for admission into an additional eleven (11) jurisdictions including the District of Columbia and the state of New York.
